201-1.01 Registration and renewals

201-1.02 Temporary certificates

201-1.01 Registration and renewals.—

(1) Any person without a current registration certificate cannot use the designation of Landscape Architect, Landscape Architecture or Landscape Architectural, or advertise any other designation or description tending to convey the impression that he is a Landscape Architect.

(2) Any registrant currently serving in the Armed Forces who fails to re-register shall be exempt from same so long as said registrant maintains his military status.

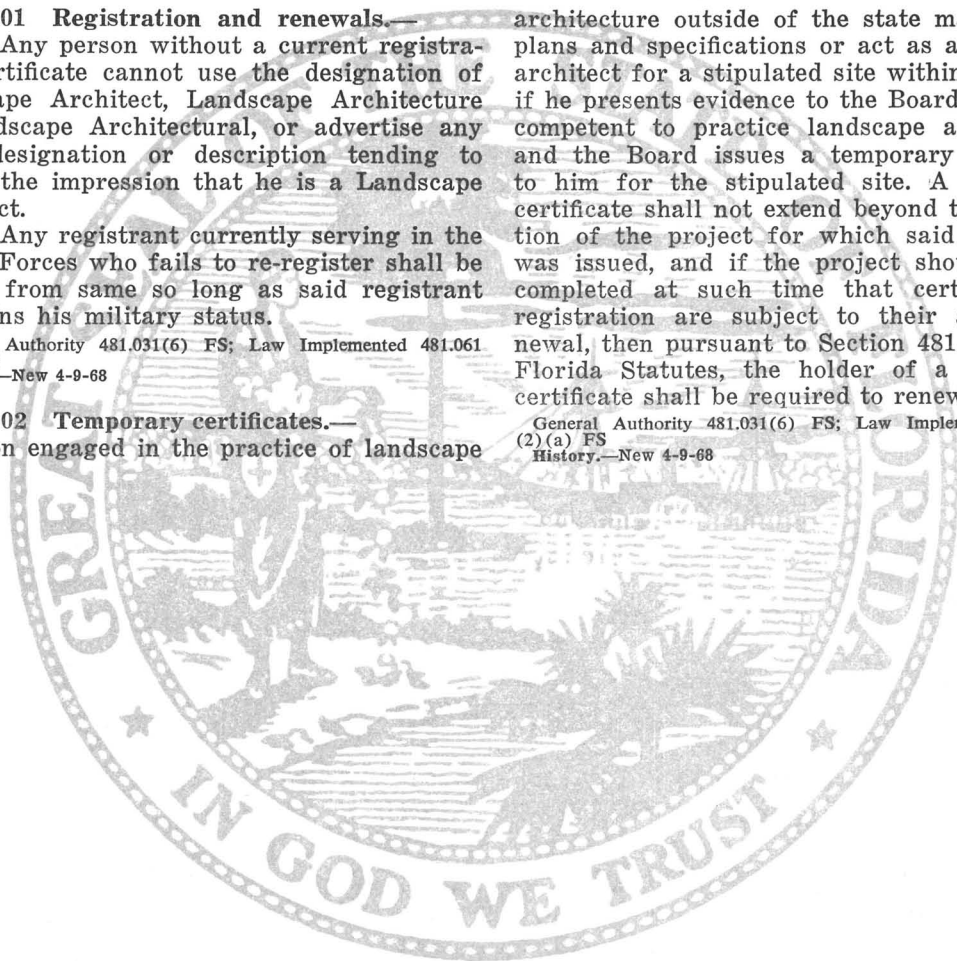

201-1.02 Temporary certificates.—

A person engaged in the practice of landscape

architecture outside of the state may prepare plans and specifications or act as a landscape architect for a stipulated site within this state if he presents evidence to the Board that he is competent to practice landscape architecture and the Board issues a temporary certificate to him for the stipulated site. A temporary certificate shall not extend beyond the completion of the project for which said certificate was issued, and if the project should not be completed at such time that certificates of registration are subject to their annual renewal, then pursuant to Section 481.061(2)(a), Florida Statutes, the holder of a temporary certificate shall be required to renew the same.

201-2.01 Examination procedure.—

(1) Provisions shall be made by the Florida Board of Landscape Architects for holding not less than one examination each year and such other examinations as the Board may deem necessary or proper when the number of applicants requires.

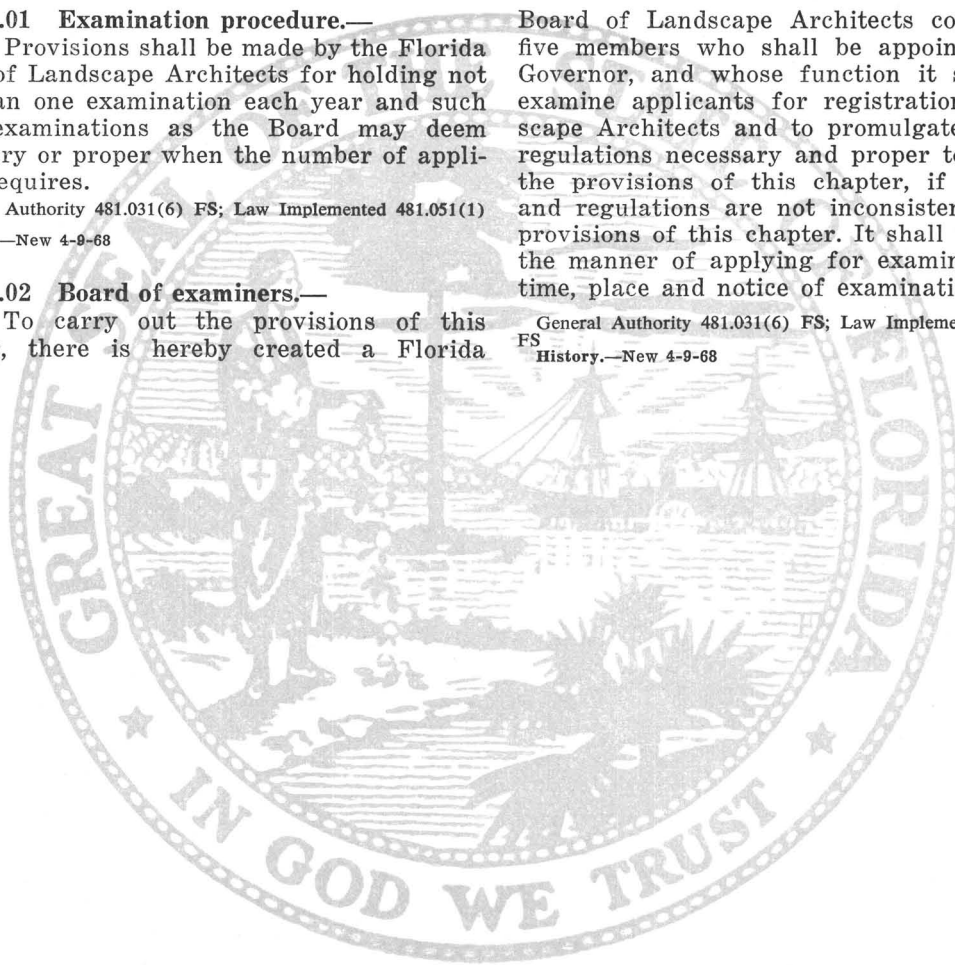
201-2.02 Board of examiners.—

(1) To carry out the provisions of this chapter, there is hereby created a Florida

201-2.02 Board of examiners

Board of Landscape Architects consisting of five members who shall be appointed by the Governor, and whose function it shall be to examine applicants for registration as Landscape Architects and to promulgate rules and regulations necessary and proper to carry out the provisions of this chapter, if such rules and regulations are not inconsistent with the provisions of this chapter. It shall provide for the manner of applying for examinations, the time, place and notice of examinations.
